



Letter of Commitment to Sign Contract

This letter serves as an official commitment from the University of Debrecen (UD) to enter into a legally binding agreement (Agency contract) detailed in Annex 1 with Bezalel Study Consultants FZ - LLC upon successful enrollment of a student to our institution. This commitment is applicable for India as recruitment area. The terms and conditions specified in Annex 1 shall govern the contractual relationship between the University of Debrecen and Bezalel Study Consultants FZ - LLC.

Please note that although you will be in direct contract with UD, the authorized South Asia Regional Office of the UD will be responsible for the coordination of recruitment and the disbursement of commission payments. In view of this, it is essential that you enter into a separate contract with the authorized South Asia Regional Office of the UD in order to carry out the recruitment tasks, as well as for the remuneration following successful recruitment. The agreement to be signed by Bezalel Study Consultants FZ - LLC and the South Asia Regional Office is detailed in Annex 2.

Please note that if you do not present your signed agreement with the South Asia Regional Office to UD within 30 days of the conclusion of the contract between you and UD, our institution reserves the right to terminate the previously concluded Agency contract, after which you will not be entitled to any rights, remuneration or compensation.

In light of this commitment, the UD is pleased to grant you access to our agent training videos and the Regional Office may perform further agent trainings as well, on demand. This access is granted to streamline our collaboration and enhance your proficiency in guiding prospective students through the application process.

During the commitment period you are required

- To represent and promote the university in a manner that upholds the esteemed reputation of the UD. We expect all endeavors undertaken in partnership with our institution to align closely with our standards of excellence, integrity, and ethical conduct;
- To pursue your activity in your own name, at your own risk and costs;
- Not to recruit students for the faculties, organizational units of other Hungarian universities offering programs identical with the ones offered by the University of Debrecen;
- To provide full information to the applicants on the rate of service fees to be paid to the University of Debrecen, on the method of payment and on the fees they are entitled to collect;
- To retain and handle all information and data obtained during the commitment period in connection with, in pursuance of the regulations on the protection of business secrets under this commitment and afterwards as well.

Based on this Letter of Commitment, UD is entitled to check your compliance with the above obligations, to request documents and information from you in this regard. If you have breached these obligations based on the documents provided, UD will consider its cooperation with you to have failed, and in this case you are obliged to compensate UD for all damages and to immediately terminate all recruitment activities in accordance with this Letter of Commitment.

This commitment is binding and enforceable by law, and any breach of this commitment may result in legal consequences. The parties agree to negotiate in good faith to resolve any disputes that may arise during the commitment period.

Unless withdrawn by UD, this letter is valid until 31st December 2025, after which it shall expire unless otherwise mutually agreed upon in writing by both parties.

We believe that this commitment will contribute to the advancement of our shared goals and objectives, promoting academic excellence and creating a mutually beneficial partnership.
